Letter of engagement for the planning of Helicopter Training Areas 2026

1. [Ministerial Decree dated 20 Dec 24 defining the UAS geographical zones in Belgium](#)
2. [AIP Belgium & Luxembourg ENR 5.2 Chapter 2 Helicopter Training Areas](#)

1. This letter of engagement aims at facilitating the planning of civil UAS flights. It is an engagement from Defence towards all civil UAS operators to avoid, as far as practical, the booking of some Helicopter Training Areas during specific day(s) of the week.
2. Context:
 - a. For safety reasons and in accordance with Ref 1:
 - i. If LFA 11 or an HTA is active, only operations with UAS up to 900 grams and flying at or below 35 feet AGL are allowed, except if they are operated from a model aircraft terrain, in respect to its operational conditions and with the approval of its operator.
 - ii. If one or a combination of the LFA01 until LFA07 is/are active, only operations flying at or below 150 feet AGL are allowed.
 - iii. These access conditions are necessary to mitigate the potential consequences of a collision between an UAS and a helicopter or a single engine jet aircraft due to the unpredictability of very low-level flights of military helicopters or jet aircraft.
 - b. The use of the military low-level training zones is highly dependent on the meteorological conditions. This explains why their activation is announced by NOTAM not earlier than one day prior, at 16:00LT.
3. Engagement:
 - a. In order to reconcile the military and the civil requirements, Defence will, to the best of its abilities:
 - i. Continue to book HTA "as needed", both in time and in space;
 - ii. Continue to apply the HTA cancellation procedure when a booked HTA is no longer required;
 - iii. Promote the use of the HTA calendar in enclosure B. This calendar will be adhered to as far as the weather conditions and the planning of largescale exercises are permitting its application.
